Doctoral position in the field of political science or history, on the governance of new mountain commons (100%)

Introduction

Presentation

The Institute of Geography and Sustainability (IGD) seeks to fill a position of **Doctoral researcher** for a period of 4 years within the SNSF-funded project *Mountain COMmons: Questioning past and present Commons to address territorial development issues in MOUNTain areas (ComMount)* (more information : <https://tinyurl.com/ywtr7dcj>).

The IGD is an interdisciplinary community of about 130 academics that work in the fields of Geography and Sustainability. With 27 professors and lecturers, and more than 60 PhD students and Post-docs, the department offers a vibrant, stimulating environment for cutting-edge research. It hosts regular lecture series and distinguished guest researchers from around the world.

Your responsibilities

The successful candidate will participate in the above-mentioned research project that UNIL (Prof. Leila Kebir, Prof. Emmanuel Reynard, and Prof. Stéphane Nahrath) is carrying out in collaboration with the Università della Svizzera italiana (Prof. Luigi Lorenzetti and Dr. Roberto Leggero) and the Centre régional d'étude des populations alpines CREPA (Dr. Yann Decorzant).

He/she will contribute to the realisation of the different research tasks as well as to the project management tasks. **In this framework, he/she will complete a PhD thesis in history or political science (depending on the profile recruited) under the supervision of Prof. Luigi Lorenzetti (Università della Svizzera italiana) and Prof. Stéphane Nahrath (UNIL-IDHEAP).**

In a context of global change, mountains are faced with major economic, social and environmental challenges. Among the different possible levers to respond and adapt to these challenges, "new commons" appear as potential ones. This interdisciplinary project (economics, geography, history and political science) aims to understand how these new commons - i.e. commons associated to the provision of goods and services from resources other than natural ones - are structured and organised and how they relate (or not) to the 'historical commons' that still exist in mountain regions. Furthermore, we question the geographical, social, political and economic conditions of their emergence and development. In order to answer these questions, we will conduct in-depth interdisciplinary

case studies in the Swiss Alpine region. This will allow us to understand the role of these new commons as a lever for the evolution of territorial governance (object of the present PhD thesis) and for territorial development.

In parallel to the thesis carried out within the framework of this position, a second thesis on the territorial issues of new mountain commons will be carried out in the field of economic geography. The two PhD students will work closely together throughout the project.

Your qualifications

- Master degree in social sciences (political science/public administration, history, sociology, anthropology, etc.). Knowledge on commons would be appreciated;
- Strong interest in the historical analysis of territorial governance of mountain regions;
- Taste for research, both theoretical (conceptualization) and empirical (field surveys, documentary and archival studies);
- Good knowledge of qualitative research methods, including archival work;
- Good interpersonal skills as well as initiative and autonomy;
- At least passive knowledge of French (communication language); good knowledge of English required (oral and written) as well as some knowledge of German and/or Italian;
- Ability to collaborate in an interdisciplinary research team.

What the position offers you

We offer a stimulating work environment and atmosphere, with dedicated support for developing an academic career. Members of our research groups become part of international networks and benefit from opportunities to attend conferences and workshops around the world. Salary is based on the salary scale for doctoral researchers of the Swiss National Science Foundation (www.snf.ch) and additional funds for fieldwork and conferences are available. Different formation opportunities are possible at UNIL or in Swiss institutions that promote post-doctoral research.
